NCGG Internship Programme 2025

Programme Overview:

The NCGG Internship Programme offers a unique opportunity for young academic talent to gain hands-on experience in public policy, governance, and government functioning. Interns contribute through research papers, reports, and assisting in real-time governance initiatives.

Duration:

8 weeks to 6 months (Minimum attendance of 80% and successful completion mandatory for certificate).

Eligibility Criteria:

- Students or researchers seeking practical experience.
- Pursuing or completed Post-Graduation / PG Diploma / PhD / Advanced academic degrees.
- Fields of study Include:
 - **Political Science:** Public Administration, Public Policy;
 - **Engineering & Technology:** Computer Science & Engineering, Electrical, Mechanical, Civil, Chemical, Aerospace, Biotechnology, etc.;
 - **Interdisciplinary & Emerging Fields:** Applied Sciences, Applied Statistics, Digital Governance, Artificial Intelligence & Governance, Drinking Water Supply, Sanitation, Data Science & Analytics, Robotics, Energy Science, Environment Science, Sustainable Development, Cognitive Science, Public Policy.
- Age Limit: Below 30 years
- Willing to work from Delhi/Mussoorie/project locations.
- Students who have completed NCGG internship and given certificate of completion earlier will not be eligible to apply.

Required Skills:

- Strong research & analytical skills
- Excellent writing and communication
- Research articles and publications

Internship Domains:

Public policy & governance, Education, Decentralized planning, e-Governance, Public service delivery, Laws & regulations, Rural development & poverty elimination, Water, sanitation, hygiene & public health, Governance in healthcare, Sustainability, Disaster resilience

infrastructure and disaster mitigation, Sustainable urban management and urban governance, Infrastructure development, Innovation & entrepreneurship, Water resource management & river rejuvenation, Climate change, environment & clean energy, Tribal affairs, Monitoring, data analytics & evaluation, Project planning, design, management & monitoring, Natural resource management, environment & forests, Mass communication and social media.

Selection Process:

- Shortlisted candidates will be interviewed (online/offline).
- Final list announced via email and website.

(Maximum 20 interns selected per batch)

Mentorship & Honorarium:

- Interns will be assigned a mentor for monitoring and evaluation of their research work.
- A consolidated stipend/honorarium of INR 10,000 per month will be provided to each intern during the approved internship period, based on satisfactory progress in their assignment (to be approved by the mentor). No additional expenses will be payable.

Intern Responsibilities:

- Submit a research paper
- Assist in events, documentation & social media
- Prepare communication materials
- Monitor policy developments & write reports

At Completion:

- Research paper submission
- Presentation to evaluation committee/ competent authority
- Certificate of successful completion (based on evaluation)
